## Circular

In the Circular bearing No. HAD/12M-25-06/A/6631, dated 30.10.2006 issued from the end of this Department, the procedure for referral of the bodies of unnatural death from the districts of North 24 Parganas, South 24 Parganas, Howrah, Hooghly, Purba Medinipur, Nadia and Kolkata Police Authority to different Medical Colleges and the area from where such bodies of unnatural death to be referred to Medical College & Hospital Kolkata and N R S Medical College and Hospital, Kolkata for Post Mortem Examination in order to obtain Specialist opinion has been specified.

Now, in partial modification of aforesaid Circular, the area from where such bodies of unnatural death to be referred to different Medical College & Hospitals located in Kolkata and its vicinity for Post Mortem Examination in order to obtain Specialist opinion is hereby re-allocated as follows:

For rest of the districts, it will be unchanged.

The Protocol for referral of such Post Mortem cases from an institution to the MCHs for obtaining Specialist opinion will be as follows:

- The concerned Autopsy Surgeon have to submit written application to the Superintendent of the referring Hospital, citing valid reason for his inability to conduct the PM and reason for referring such cases, before recommendation for referring the case to MCH.
- The Superintendent of the referring Hospital will forward the application to the concerned Police Station mentioning the name of the MCH where the case to be referred as mentioned above,
- 3. The IC/OC of the Police Station will inform the Superintendent of Police/ Addl the Superintendent of Police (for district) or Commissioner/ Dy Commissioner (for Commissionerate) for referring the case to the Superintendent of Police/ Addl the Superintendent of Police of the concerned district or Commissioner/ Dy Commissioner of the concerned Commissionerate under whose jurisdiction the referred MCH is located.
- 4. Thereafter, the Superintendent of Police/ Addl Superintendent of Police (for district) or Commissioner/ Dy Commissioner (for Commissionerate), under whose jurisdiction the referred MCH is located, will forward the application to the Principal/ MSVP of the referred MCH
- 5. Finally, the Principal/ MSVP of the referred MCH will forward the application to the Head of the Department of Forensic Medicine and Toxicology of the referred MCH for conducting the Post Mortem examination after receiving all the relevant documents as mention in the SOP for Post Mortem examination.

This protocol should strictly be followed.
